## Preface

This statistical release presents information on civil marriages that were registered by the Department of Home Affairs in 2008. In addition for the first time presents information on customary marriages registered between 2003 and 2008 and civil unions registered between 2007 and 2008. The release also reports on the 2008 divorces that were granted by the Department of Justice and Constitutional Development through its divorce courts that had reached Stats SA at the time of publication.

## KEY FINDINGS

### 1. Introduction

There are two main sources of marriage and divorce statistics in South Africa namely those compiled from censuses and surveys and those compiled from vital registration and administrative records. The data from each of these sources give different aspects of information on marriages and divorces in a given population. Census and survey data are by nature, subjective individual information that provide cross-sectional data on individuals' marital status (single, married, divorced, widowed, etc). Therefore marriage and divorce in this context cover different types of marriages and associated divorces that took place at different periods in the people's lives. However, not all types of marriages and divorces are registered. The specific types of marriage and divorce that can be registered are stipulated and governed by legal frameworks. Unlike surveys, data collection is based on continuous recording of events (marriages and divorces) as they take place.

The *Marriages and divorces statistical release (P0307)* publishes annual marriage and divorce data that are collected through administrative records / registration systems and not through censuses / surveys. Until 2007, the published data in the annual release covered only civil marriages. Civil marriage is administered by the Department of Home Affairs (DHA) through the Marriage Act, 1961 (Act No. 25 of 1961). Starting with the 2008 annual release, Stats SA will be publishing data on registered customary marriages and civil unions / partnerships. The recognition of Customary Marriages Act, 1998 (Act No. 120 of 1998) came into operation on 15<sup>th</sup> November 2000. Data on registered customary marriages are available from DHA from 2003. The solemnisation and registration of a civil union, either by way of a civil marriage or a civil union partnership is governed by the Civil Union Act, 2006 (Act No 17 of 2006). The Civil Union Act came into operation on 30<sup>th</sup> November 2006. Data on registered civil unions are available from DHA from 2007. The Department of Justice and Constitutional Development (DoJ&CD) is mandated through the Divorce Act, 1979 (Act No. 70 of 1979) to handle matters of dissolution of civil marriages. Data on granted divorces (from civil marriages) are obtained from DoJ&CD, through its divorce courts.

The current information in the release is based on civil marriages registered in 2008 and divorces from civil marriages that were granted in 2008; customary marriages registered from 2003 to 2008; and civil unions that were registered in 2007 and 2008. The findings of the data are presented in two separate sections: marriages and divorces. It is important to note that: first, although both the data on civil marriages and divorces were collected in the same year, they are not linked to each other. Marriages reported here are civil marriages that were registered in 2008 and customary marriages registered between 2003 and 2008. Divorces are the divorce cases whose application for divorce was granted in 2008. Publication of statistics on divorces from registered customary marriages and civil unions will be available when sufficient data become available.

### 2. Marriages

#### 2.1 Civil marriages

##### 2.1.1 Trends in marriages (1999-2008)

In 2008, 186 522 marriages were registered. This number includes 959 marriages of South African citizens solemnised outside the borders of South Africa but were registered in South Africa. Information provided in Table 1 shows that the number of registered marriages has generally been increasing over the last ten years (1999–2008). In 1999, 140 458 marriages were registered. This number had increased to 186 522 in 2008 showing an annual increase of 2,9% since 1999. However, there were observed annual fluctuations particularly the sudden declines in 2001 and 2004 as well as the sharp increase in 2002. The 2008 figure of 186 522 shows an increase of 3 492 (1,9%) from 183 030 marriages recorded in 2007.

As shown in Figure 1, the summer months, beginning from September and peaking in December, continue to be the most popular months for marriages. In 2008, the highest number of marriages 30 044 (16,1%), took place in December compared to June that recorded the lowest, 12 307 (6,6%).

##### 2.1.2 Solemnisation of marriages

Only licensed marriage officers are required by the Marriage Act to solemnise civil marriages. Civil marriages are generally solemnised at the offices of the DHA and at chapels or religious buildings. In Table 2, these types of marriages are grouped under 'civil' i.e. marriages solemnised by lay persons and 'religious' marriages solemnised by priests / religious persons. The 2008 data show that 95 898 (51,4%) of the 186 522 marriages were solemnised by civil rites and 63 866 (34,2%) by religious rites. The type of solemnisation rite was not specified in 26 758 (14,4%) marriages.

After the solemnisation ceremony, the marriage officer issues the couple with an unabridged marriage certificate (BI-27) free of charge and submits the marriage register to the nearest DHA office for the recording of the marriage particulars in the National Population Register (NPR). Therefore the place (e.g. municipality or province) of registration of the marriage is not necessarily the place of usual residence of the couple. In 2008, the highest number of marriages solemnised by civil rites were registered in Gauteng and the lowest in Northern Cape. The highest number of marriages solemnised by religious rites were recorded in KwaZulu-Natal and the lowest in Limpopo.

### 2.1.3 Marital status at the time of marriage

Data presented in Table 3 indicate that most of the marriages in 2008 were first time marriages. Overall, 152 951 (82,0%) men and 159 060 (85,3%) women had never been married. Among those who were remarrying, there were 5 772 (3,1%) male divorcees and 3 758 (2,0%) widowers. For the brides, there were 4 151 (2,2%) divorcees and 3 167 (1,7%) widows. The marital status of 24 041 (12,9%) bridegrooms and 20 144 brides (10,8%) was not recorded. However (60,6%), of the 9 530 remarrying men were divorcees but the proportion of divorcees among the 7 589 women who were remarrying was slightly above half (4 151 or 56,7%). Irrespective of their marital status men married partners who had never been married (see Tables 4). Thus, 92,0%, 53,9% and 81,0% never married men, divorcees and widowers respectively married women who had never married.

### 2.1.4 Age at the time of marriage

Demographers are interested in the age at first marriage or union because of its theoretical link to exposure to the risk of pregnancy, childbearing and ultimately to fertility. This link tends to be weakened in populations where pre-marital fertility is widespread. Nevertheless, age at first marriage or union continues to be a good proxy for measuring not only fertility but other health and socio-economic indicators relating particularly to the role and status of women in society. The importance of this indicator is underscored in South Africa through the Marriage Act that puts restrictions on marriage (with respect to civil marriages) involving minors (persons under 21 years old). These minors unless (provided they have married before) require parental or guardian consent before entering into a civil marriage. Furthermore, boys under 18 and girls under 15 years of age, in addition to the consent of the parents or guardians, require the consent of the Minister of Home Affairs before marriage. In 2008, marriages of 930 men and 6 774 women aged less than 21 years were registered. As expected, there were insignificantly low numbers of registered marriages of men (15) younger than 18 years and women (5) younger than 15 years.

Women enter marriage for the first time at younger ages than men. In 2008, the median age for grooms was 34 years compared to 29 years for brides. Major differences however, are observed when the marital status at the time of current marriage is considered (see Figures 2, 3a, 3b, 3c and 3d). For first time marriages, the median age for bachelors was 32 years and that of spinsters was 29 years giving a difference of three years. The age at first marriage for both men and women has remained the same as 2006. For remarriages, the median age of divorced men was 52 years compared to 46 years for their female counterparts yielding an age gap of six years. Similarly, the median ages for widowers and widows were 45 years and 29 years respectively resulting in a 16 years' gap. Despite the fact that men tend to marry younger women, in 2008 14,6% of bridegroom were younger than their brides whilst 7,1% were of the same age (see Tables 4, Figures 4a, 4b, and 4c).

## 2.2 Customary marriages

### 2.2.1 Trends in the registration of customary marriages (2003-2008)

In 2003, 17 283 customary marriages were registered. As presented in Table 6, the number of registered marriages has been fluctuating since 2003. The lowest recorded number (14 039) was in 2006 whilst the highest 20 301 was in 2004. The number dropped to 16 003 in 2008. Since the registration of customary marriages is relatively new, it is of interest to examine the proportion of customary marriages registered in the year they occurred. It is observed from data in Figure 5 that this proportion has never reached 10,0%. It ranged between 4,7% and 8,5%. The proportion for 2008 is 7,2%.

### 2.2.2 Marital status at the time of customary marriage

In the absence of data on marital status at the time of the registration of customary marriage, it is not possible to distinguish between first time spouses and those who have married before (i.e. spouse in polygamous marriages, divorcees, widows and widowers).

### 2.2.3 Age at the time of customary marriage

Table 7, shows the age distribution of bridegrooms and brides at the time of customary marriage. The proportion of customary marriages with bridegrooms aged less than 18 years varied from 0,4% in 2003 to 0,8 in 2008. Whilst the proportion of brides aged less than 18 years varied from 4,0% in 2003 to 8,3% in 2008.

As observed from Figure 6, the bridegrooms are generally older than the brides. In 2008, the median age of bridegrooms was 31 years and that of brides was 25 years. The median age ranges from 30 years to 32 years for bridegrooms and for brides from 24 years to 27 years for brides between 2003 and 2008 respectively. Figure 7 further shows that generally about 85,0% of bridegrooms are older than their brides whilst around 10,0% and 5,0% are younger and of the same age respectively.

## 2.3 Civil unions

According to the Civil Union Act (2006), a civil union means “the voluntary union of two persons who are both 18 years of age or older, which is solemnised and registered by way of either a marriage or a civil partnership, in accordance with the procedures prescribed in this Act”.

### 2.3.1 Trends in the registration of civil unions (2007-2008)

In 2007, 80 civil unions were registered. A year later, the number of registrations had increased to 732. The provincial distribution of registered civil unions indicates (see Table 8) that most of the civil unions were registered in Gauteng and Western Cape. In 2007, 61,3% of all registered civil unions took place in Gauteng. The proportion dropped to 49,0% in 2008. Western Cape registered 20,0% and 26,1% in 2007 and 2008 respectively. Although no civil unions were registered in Eastern Cape and Limpopo in 2007, they recorded 41 and 15 registrations respectively in 2008.

### 2.3.2 Age at the time of civil union

The average difference in ages between spouses was 7,7 years in 2007, and 7,3 years in 2008. Data from both 2007 and 2008 registration shows that spouses 1 are older than spouses 2 (see Figure 8 and Table 9). In 2007 the median age for spouses 1 was 40 years and that of spouses 2 was 36 years. For those who registered in 2008, the median ages for spouses 1 and spouses 2 have dropped to 38 years and 35 years respectively. Figure 9 further indicates that in 2007, 56,2% of first spouses were older than their spouses. The proportion of those younger than or of the same age as their spouses were 33,8% and 10,0% respectively. A year later, the proportion of first spouses older than their spouses had increase to 63,5% whilst those younger than or of the same age has dropped to 30,1% and 6,4% respectively.

## 3. Divorces

### 3.1 Trends in divorces (1999-2008)

The published data on divorces presented in Table 10 indicate that the number of granted cases has been fluctuating between 37 098 and 28 924 per annum in the past decade (1999-2008). The distribution of couples divorcing by population group shows that there were more divorces among the African population group compared to the other groups. Despite the general fluctuations, the proportions of divorces from the mixed and the African groups have been increasing whilst that of the White group has been declining in the past ten years. In 1999 the African, Indian/Asian, White and mixed groups made up 18,4%; 5,3%; 39,9% and 1,0% of the number of divorces respectively. However, in 2008 the contribution of the African, Indian/Asian and mixed groups increased to 35,0%; 6,2% and 3,1% respectively whilst that of the White group declined to 32,8%.

### 3.2 Plaintiff

The 2008 data reveal that there were more female (50,6%) than male (37,8%) plaintiffs (see Table 11). However, there were significant differences among population groups. Among African plaintiffs, more husbands (43,5%) than wives (41,1%) initiated the divorce. This is in sharp contrast to the other population groups, particularly among the White (58,0%) and the Coloured (57,9%) whereby most divorces were initiated by women.

Table 12 provides information on the occupation of the plaintiffs. Even though a high proportion of the plaintiffs did not indicate the type of occupation they were engaged in at the time of divorce, the highest percentage of wives

(19,8%) were in clerical and sales occupations whereas husbands (14,9%) were in managerial and administrative occupations. Very few plaintiffs were in farming and related occupations.

### **3.3 Solemnisation of dissolving marriage**

It is observed from Table 13 that 49,7% of all the divorce cases were from marriages that were solemnised by religious rites and 42,9% by civil rites. A similar pattern was also found among all population groups except among the White population group whereby only 18,9% of divorces were those of marriages solemnised by civil rites.

### **3.4 Number of times married**

The 2008 divorce cases were mainly from first marriages. The pattern of remarriages among husbands was quite similar to that of the wives (see Table 14). Slightly fewer (76,4%) husbands were from first marriages compared to 77,1% of wives. Approximately 9,0% were second time divorcees for both husbands and wives. About 2,0% of husbands and wives were getting divorced for at least the third time.

### **3.5 Age at the time of divorce**

The median age at divorce in 2008 was 41 for men and 38 for women. Figure 10 shows that African men had the highest median age (43) at divorce. Women from the mixed and India/Asian group had the lowest median age (36 years). Detailed information on age by population groups are presented in Figures 11 and 12 as well as Tables 15 and 16.

### **3.6 Duration of marriage of those divorcing**

The median duration of marriage in 2008 was 9 years. Detailed information on the duration of marriages by age groups for husbands and wives are given in Table 17 and Table 18 respectively. The largest number of divorces (7 859 or 27,2%) lasted five to nine years. This group is followed by marriages that lasted less than five years (6 143 or 21,2%). Thus, almost half (48,4%) of the 28 924 divorces in 2008 were from marriages that lasted less than 10 years. As the duration of marriages increased the number of divorces decreased. Irrespective of the population group of the divorcees (see Figure 13), the distribution of divorces continues to be skewed towards earlier years of marriage.

### **3.7 Divorces involving couples with children**

In 2008, there were 26 947 children (younger than 18 years old) involved in divorce. It is observed from Table 19, that 16 370 (56,6%) of the 28 924 divorces had children younger than 18 years indicating that, on the average, there was between one and two children per divorce.

Figure 1: Number of marriages by month, 2008

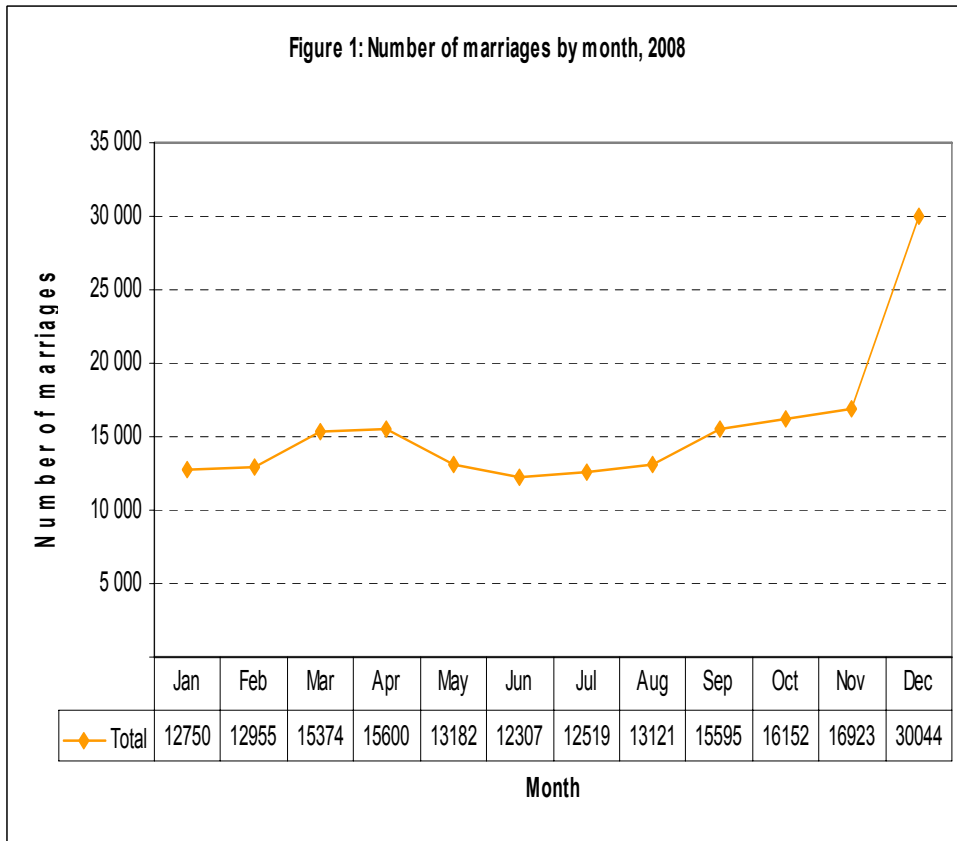
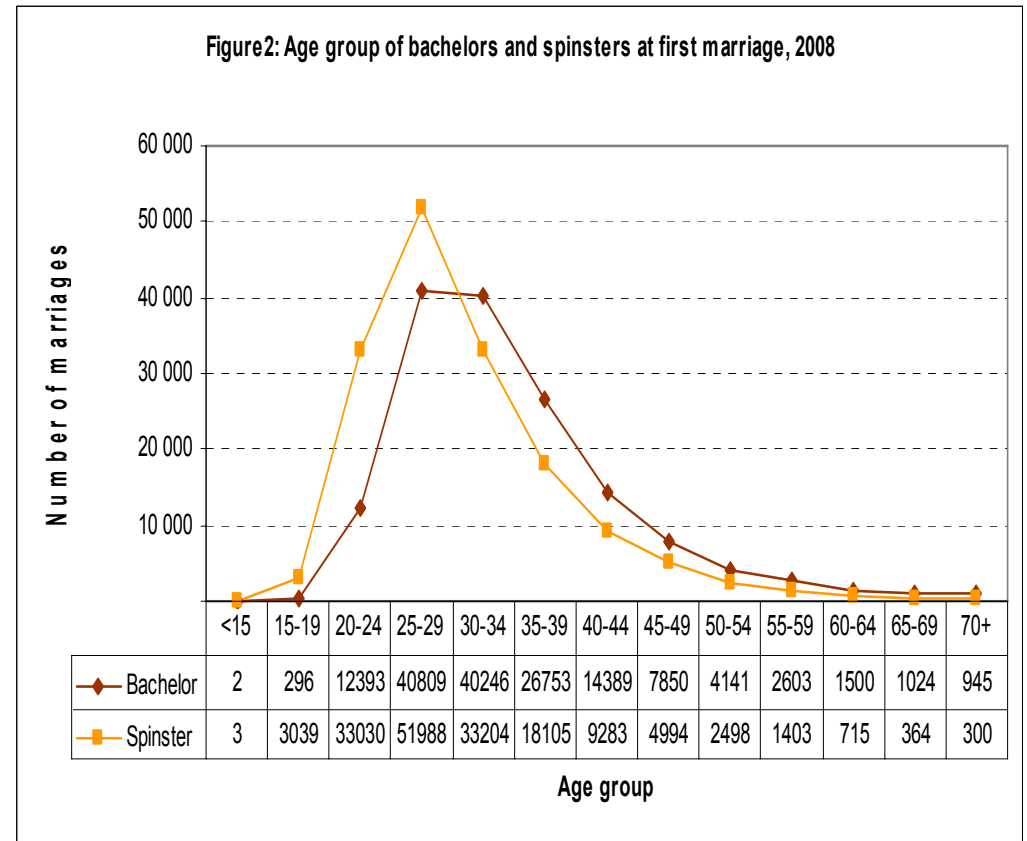
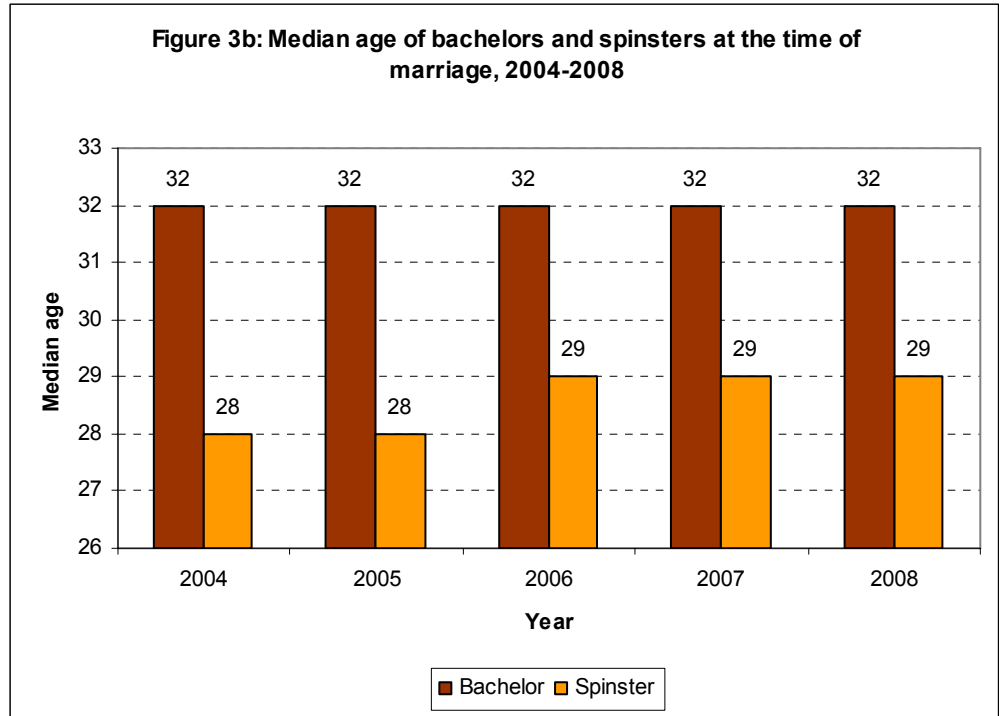
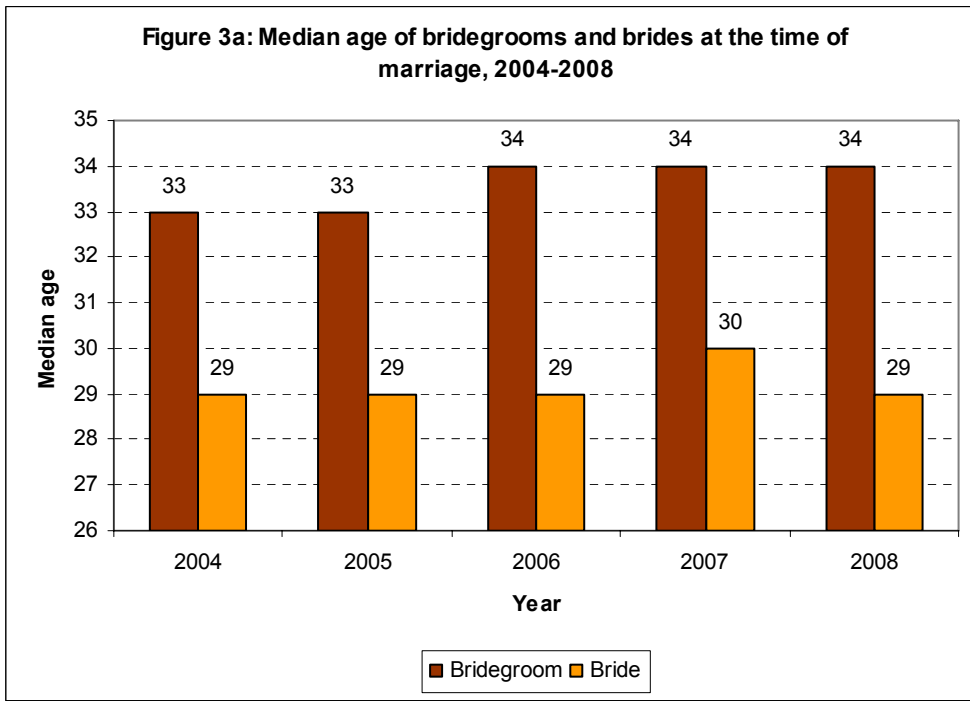
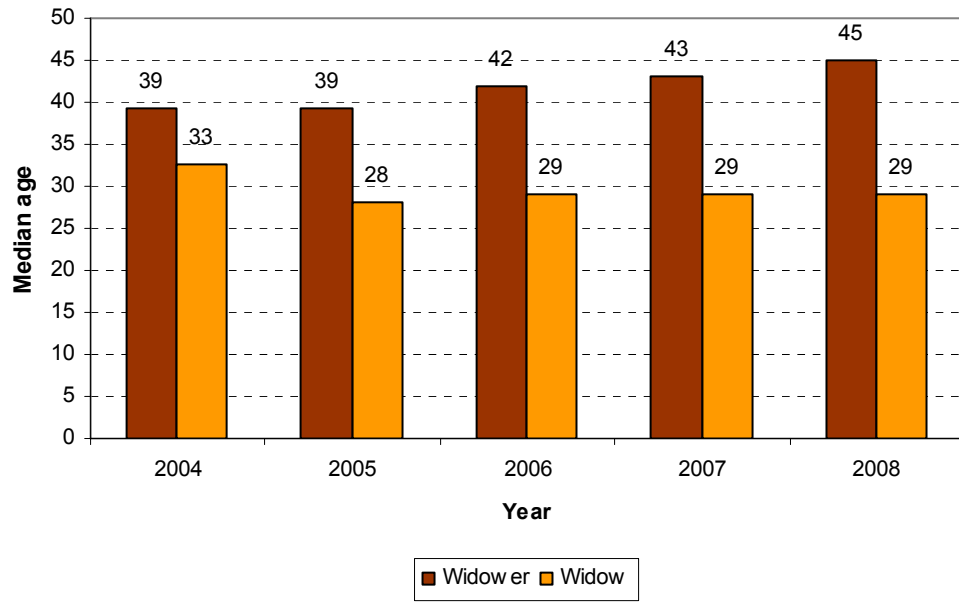


Figure 2: Age group of bachelors and spinsters at first marriage, 2008

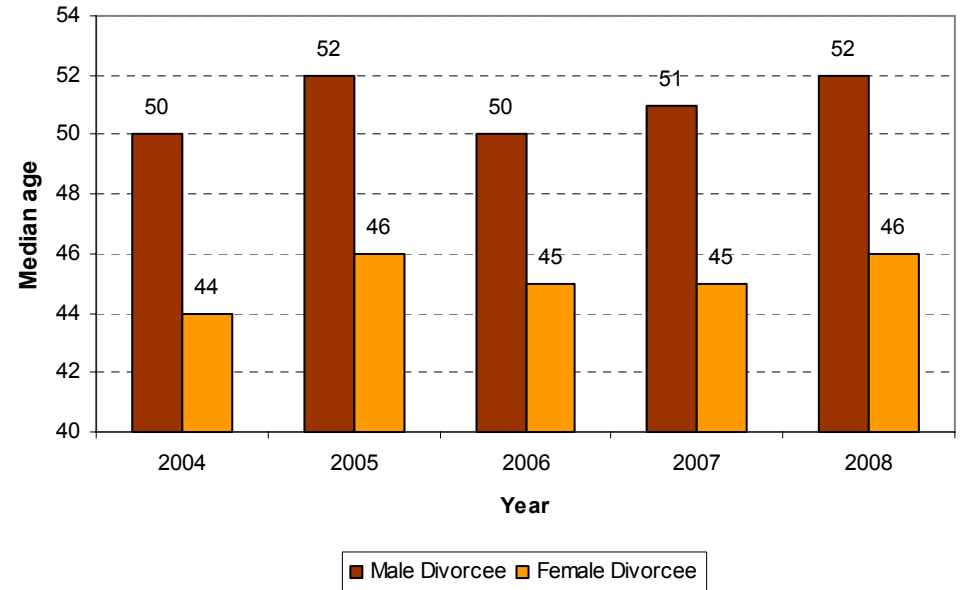




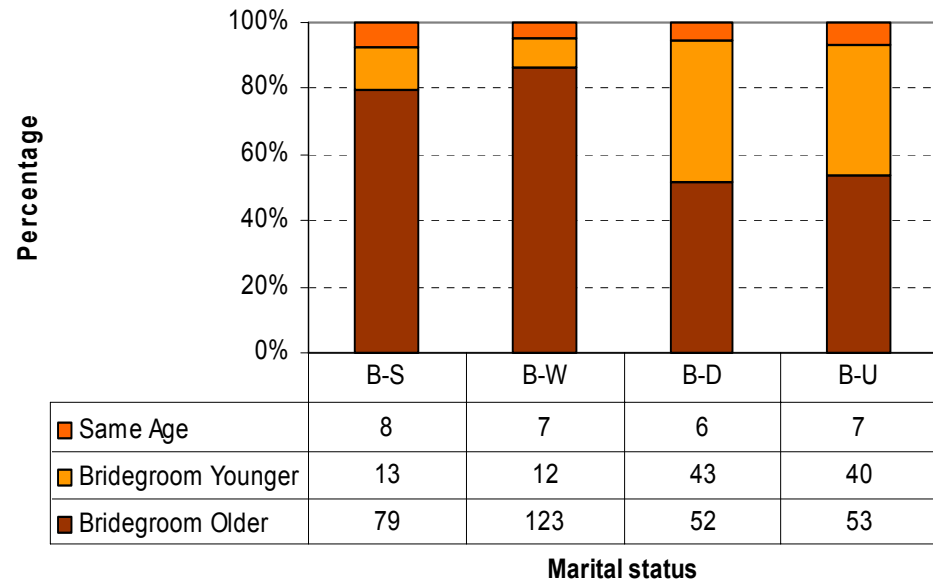
**Figure 3c: Median age of widowers and widows at the time of marriage, 2004-2008**



**Figure 3d: Median age of male and female divorcees at the time of marriage, 2004-2008**

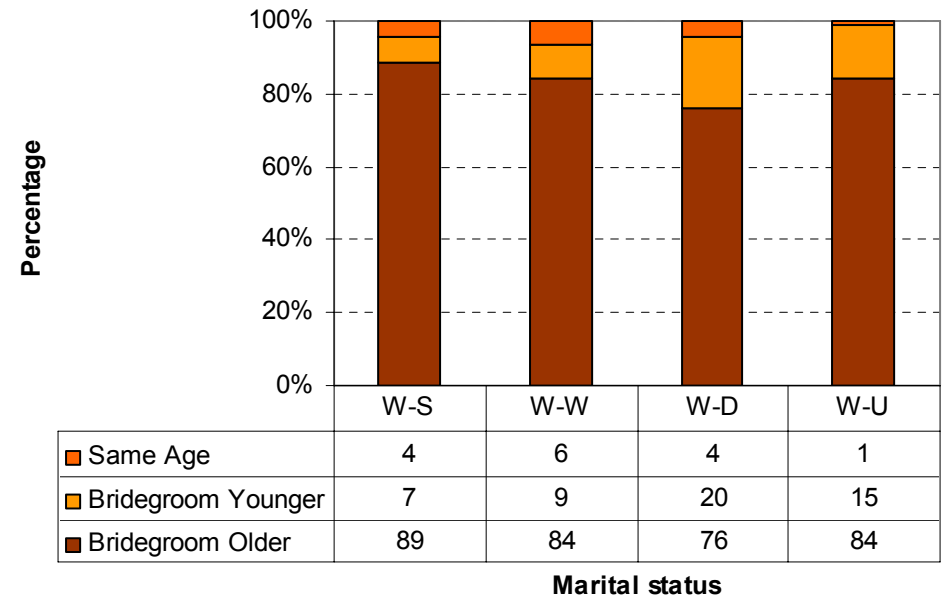


**Figure 4a: Age difference among bachelors and their brides at the time of marriage, 2008**



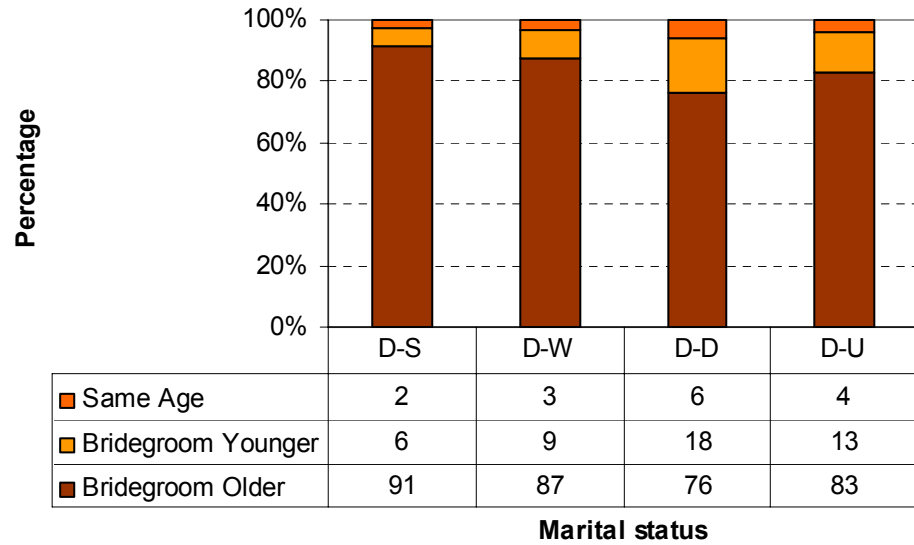
B – S = Bachelor to spinster    B – W = Bachelor to widow

**Figure 4b: Age difference among widowers and their brides at the time of their latest registered marriage, 2008**

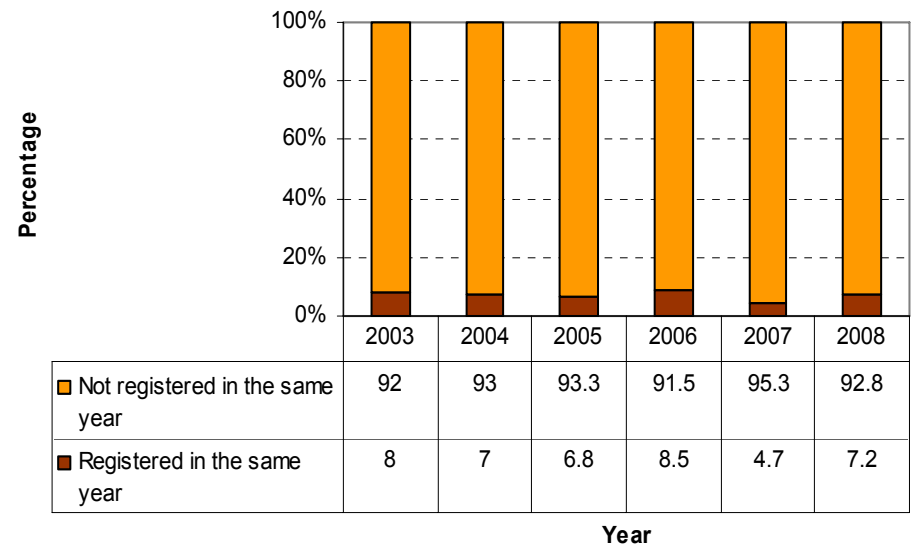


W – S = Widower to spinster    W – W = Widower to widow

**Figure 4c: Age difference among divorcees and their brides at the time of their latest registered marriage, 2008**

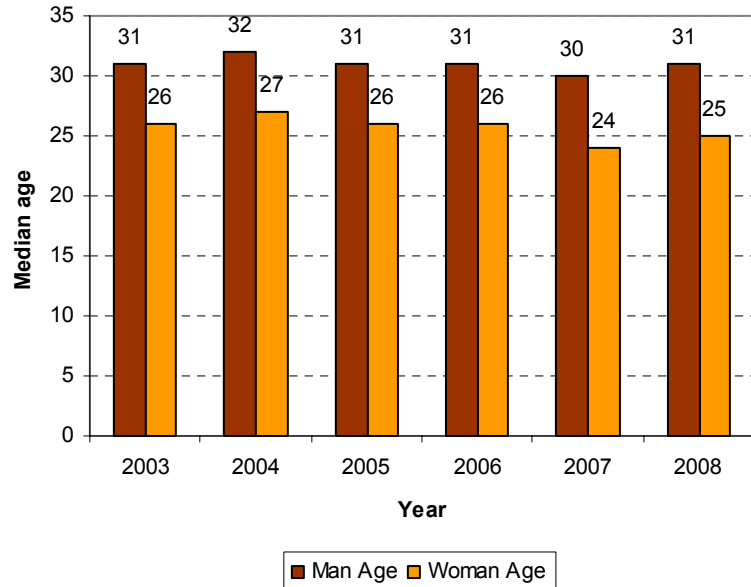


**Figure 5: The proportion of marriages that were registered in the same year they took place, 2003-2004**

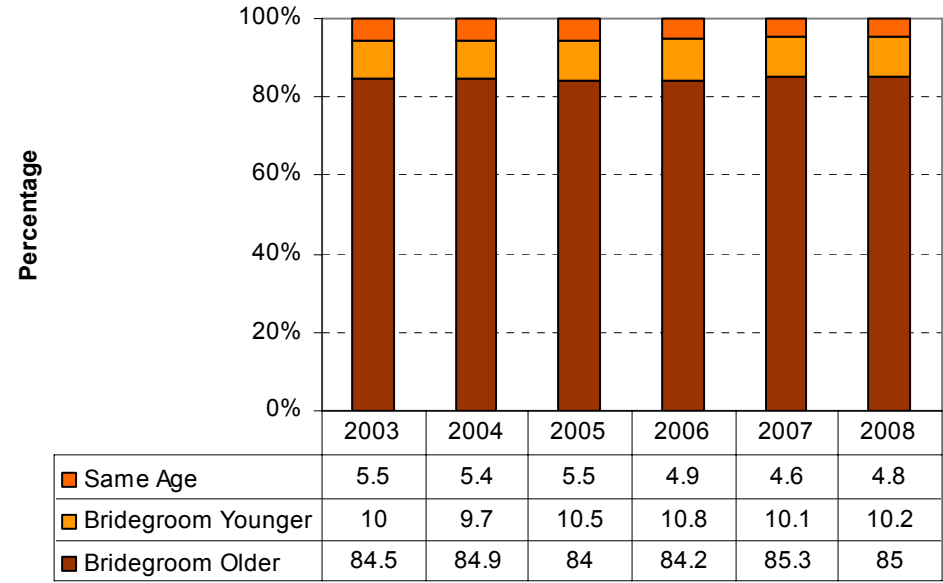


D – S = Divorcee to spinster D – W = Divorcee to widow  
 D – D = Divorcee to divorcee D – U = Divorcee to unspecified

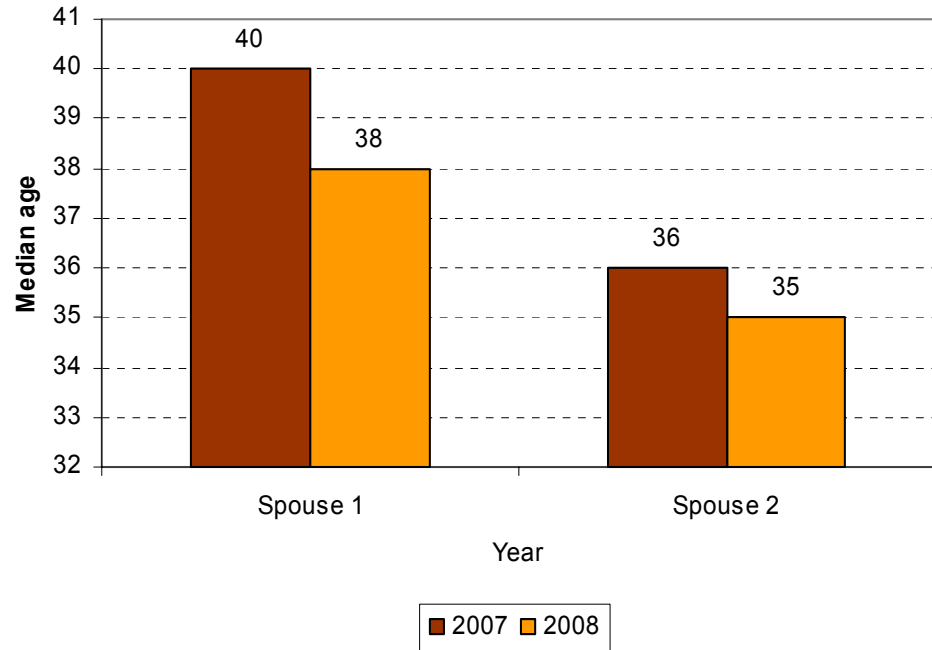
**Figure 6. Median age of bridegrooms and brides at the time of customary marriages, 2003-2008**



**Figure 7. Age difference between bridegroom and brides at the time of customary marriage, 2003-2008**



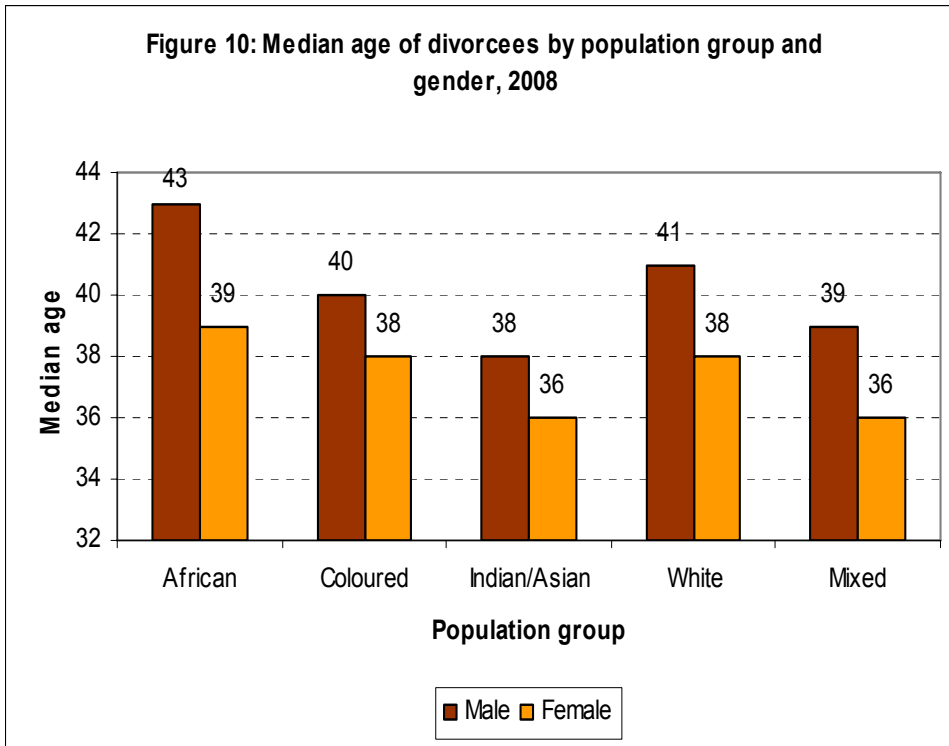
**Figure 8. Median age for spouses in civil unions, 2007-2008**



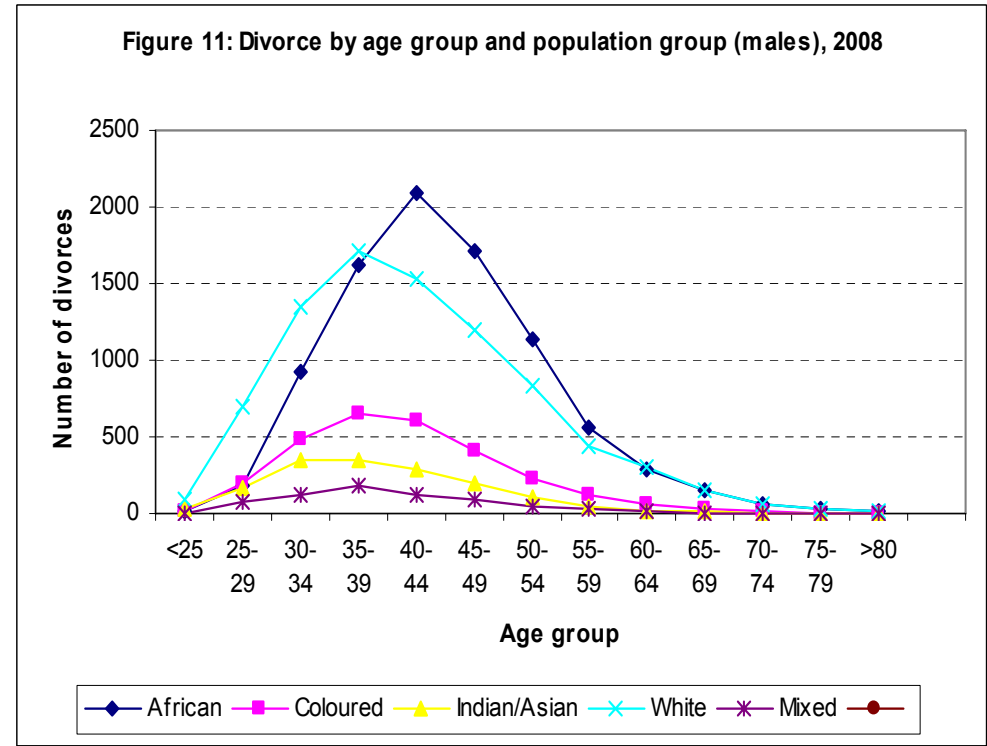
**Figure 9. Age difference between spouses at the time of thier civil union, 2007-2008**



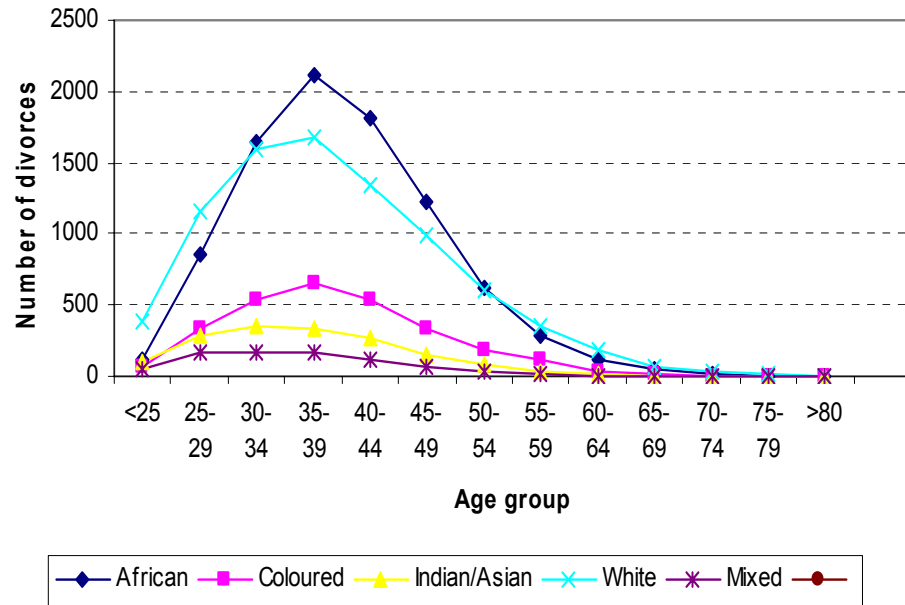
**Figure 10: Median age of divorcees by population group and gender, 2008**



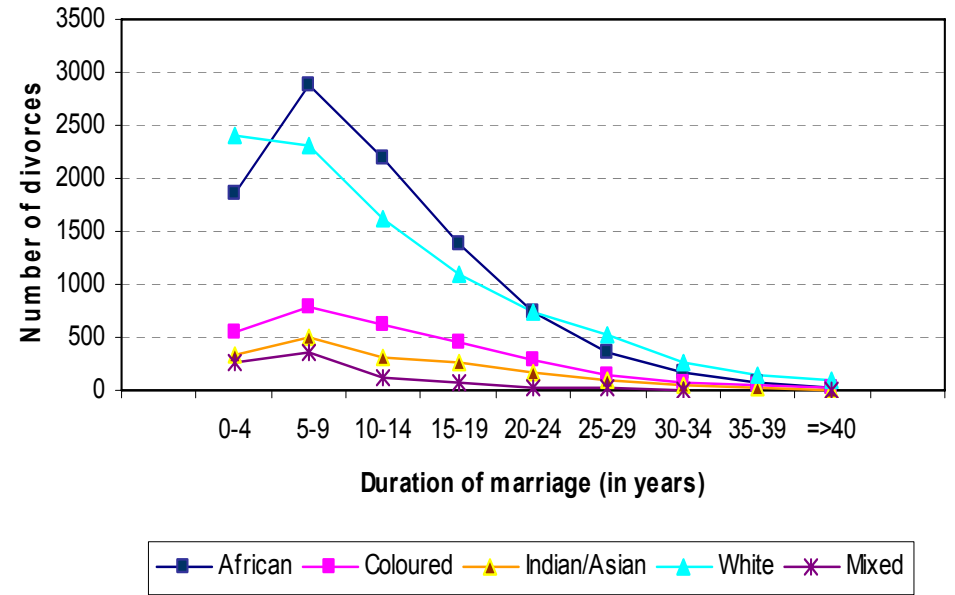
**Figure 11: Divorce by age group and population group (males), 2008**

## EXPLANATORY NOTES

### 1. Purpose of the statistical release

The purpose of the statistical release is to document trends in civil marriages and divorces granted in a particular year by civil courts. This statistical release presents information on the 2008 civil marriages that were registered by the Department of Home Affairs. The release also reports on the 2007 divorces that were granted by the Department of Justice and Constitutional Development through divorce courts, which had reached Stats SA at the time of publication.

### 2. Scope and Coverage

The data on marriages currently cover civil marriages and customary marriages in South Africa. Data on customary marriages and same-sex unions is not currently available. The divorce data covers only cases where application for divorce has been granted. Undocumented cases of abandonment do not appear in this statistics or divorces that have been granted by religious or traditional authorities outside the civil courts.

### 3. Data

Stats SA downloads the data on civil marriages and customary marriages from the Department of Home Affairs (DHA). The data are then processed and analysed for publication.

Data on divorces are collected from the divorce courts of the Department of Justice and Constitutional Development (DoJ & CD) using a standard structured questionnaire prepared by Stats SA. The questionnaires are completed by the courts and posted regularly to Stats SA where they are sorted and the data captured and analysed.

### 4. Limitations

The release focuses on presenting the demographic characteristics of the married and divorced persons. The information does not cover other important issues such as the causes and impact of divorce; and annulment, which is another way in which a marriage contract is dissolved.

The marriages and divorce data can not be correlated, since we report on current marriages and divorces (i.e. marriages that were registered in a particular year and the divorces that were granted in the same year).

### 5. Glossary of terms

**Civil marriage:** the term broadly covers marriages solemnised by marriage officers. In this release it is also used in the tabulations to distinguish between 'religious marriages' and 'civil marriages' i.e. marriages solemnised by religious and lay marriage officers respectively.

**Mixed population group:** refers to couples with different racial backgrounds

**Occupation:** occupation is coded using the Standard Classification of Occupations, Report No 09-90-01, first Edition, 1986 published by Stats SA.
